Will I get a tax receipt?

Yes, the Library or Village will issue a charitable tax receipt for all donations over \$20.

Why does the donation get transferred to the Village?

Under current legislation (see the Library Act), Public Library Associations can not own land or buildings. The Village is working in partnership with KDPL towards a new library and will be the owner of the building after it is constructed. KDPL will enter into a long term lease agreement with the Village to operate from the new building.

How can I be sure these funds go to the new library project?

Please specify that the donation is for the New Library Project. KDPL will transfer these funds into the Library Capital Reserve Bylaw 1257 held by the Village of Kaslo.

This bylaw is specifically for: land acquisition, site preparation, planning fees, the construction of a new library, and other future capital costs related to the library. Drawing from the reserve requires an approved resolution from Council AND a written request/ consent from KDPL.
